THE WRITINGS OF THE SUDANESE MAHDI: DR. M.I. ABŪ SALĪM'S EDITION: A PROGRESS REPORT

In 'The Writings of Muhammad Ibrahim Abu Salim', *SAJHS*, 1, 1990, 11-18, the undersigned gave a listing of Dr. Muhammad Ibrāhīm Abū Salīm's scholarly production to 1990. The present note is an update on his work on a 7-volume edition of all the writings of the Sudanese Mahdi, Muhammad b. 'Abd Allāh al-Mahdī. This work is published under the title *Al-Athār al-kāmila li'l-Imām al-Mahdī*.

So far 4 volumes have been published:

- Vol. 1: Khartoum: Khartoum University Press, 1990, 472 pp.
 The letters and related documents until the end of 1300 (November 1882).
- Vol. 2: Khartoum: Khartoum University Press, 1991, 500 pp. The letters of the year 1301 (Muḥarram to Jumādā II / November 1883 to July 1884)
- Vol 3: Khartoum: Khartoum University Press, 1991, 359 pp. The letters of the year 1301 (Rajab to Dhū'l-hijja / July to October 1884)
- Vol. 4: Khartoum: Khartoum University Press, 1992, 512 pp. The letters of the year 1302 (Muharram to Rajab / October 1884 to April 1885).

In Press:

- Vol. 5: The rest of the Letters
- Vol. 6: The Rātib (Prayer-book) and Sermons.
- *Vol.* 7: The 'Assemblies' (*majālīs*), of which five examples will be given, and indices to the 7 volumes.

These volumes will in the course of 1993 be made available outside the Sudan through Chr. Hurst publishers, London. In addition, Dr. Abu Salim has recently published a volume of
